

*The total number of investigative findings in one year do not match the number of assigned reports in that same year due to the time between date of assignment and dates of findings. A worker has 30 work days within which to complete the investigative finding, thus it is possible to have an assigned report in one year that does not have a finding completed until the following fiscal year.

Substantiated: The facts and circumstances provide clear and convincing evidence to conclude the alleged perpetrator's actions or inactions meet the KSA and KAR definition of abuse or neglect.

Unsubstantiated: The facts or circumstances do not provide clear and convincing evidence to meet the KSA and KAR definition of abuse or neglect.
