## **Kansas Child Support Services Incentives to Reduce State Owed Arrears**

### **Effective 10-12-17**

Kansas Child Support Services (CSS) offer three types of incentive programs to non-custodial parents who have State Owed Arrears; 1) Education and Certification Programs; 2) Child Support Savings Initiative/529 Savings Account; and 3) Classes and Miscellaneous Programs. Kansas Child Support does not have the authority to reduce arrears owed to the custodial parent, only State Owed Arrears.

The Kansas Child Support Services (CSS) may adjust State owed arrears for non-custodial parents for the following certification and/or programs, classes, 529 Savings Accounts and miscellaneous programs:

#### **1) Education and Certification Programs: \$750-\$2,000 based on requirements**

- Completion of GED or High School Diploma- \$1,000; GED or Diploma achieved after November 1, 2012;
- Technical/Vocational Training Programs-\$1,500 See following link for programs in Kansas.

- College Degree-Associates -\$1,500;
- College Degree-Bachelors-\$2,000;
- Culinary Certificate;-\$1,500;
- Certified Nurse's Aide-\$1,500;
- Certificate of Occupational Competency in Computer Systems and Informational Technology-\$750
- Washburn Tech (WTI) Certificate (offered at Topeka Correctional Facility)-\$1,500;
- National Center for Construction Education and Research (NCCER) includes specific skills training programs only, and does not include pre-requisite and orientation classes. -\$1,500;
- Manufacturing Skills Certificate (offered at Topeka and Larned Correctional Facilities)- \$400 for completion of 8 hr course;

## **2) Child Support Savings Initiative (CSSI)/529 Savings Account**

Kansas Child Support Services will adjust State Owed Arrears with \$2.00 for every \$1.00 that is paid into the Child Support Services 529 savings account for each child account. To be eligible for this adjustment, the monthly current child support needs to be paid in full and at least \$1.00 towards Arrears is paid in the same month as the deposit to the 529 account. All child support payments are made through the Kansas Payment Center and all 529 deposits are made through Learning Quest. ## **3) Classes**

Kansas Child Support Services may adjust State Owed Arrears for financial, parenting, fatherhood, workforce and additional miscellaneous approved classes. Adjustment in the amount of \$50/hour for the first 15 hours and then \$25/hour for each additional hour may be provided. A maximum of \$2,500 may be adjusted towards State Owed Arrears. Classes must be pre-approved with agendas, timeframes, and class information. Please contact the CSS Program Administrator for potential class eligibility, if specific program is not included below. #### **Approved MISC Classes:**

- **New Beginnings:** This program involves people living in transitional housing and it is requested that they do not work while participating in the year long program. If case is for arrears only, non-custodial parents can pay \$1 month (if arrears only case) to the Kansas Payment Center while living and participating in the program. In addition, if the non-custodial parent participates in the 4 modules (each module lasts 3 months), \$500 of state arrears will be written off per completion of each module (max \$2000).
