## V. APPLICATION PROCESS

**Letter of Intent** – DCF requests that prospective applicants submit a letter of intent (LOI) prior to the submission grant application.

Although a LOI is not required, is not binding, and does not enter into the review of a subsequent application, the information that it contains allows DCF staff to estimate the potential review workload and plan for the review.

Prospective applicants are requested to submit an electronic LOI. The LOI must include the following, and must be e-mailed to the DCF Pre-Award Manager at <u>dcfgrants@ks.gov</u> no later than 2 p.m. CST on *February* 17, 2023:

- 1. Name and address of the applicant agency
- 2. Statement indicating their intent to apply
- 3. Title of RFP
- 4. Telephone number and email address of the contact person
