This amendment is made and entered into this 01 day of July, 2024 by and between Foster Adopt Connect, Inc, whose address is 18600 E 37th Terrace S, Independence, MO 64059-1707, hereinafter referred to as (Grantee) Foster Adopt Connect, Inc, and the Secretary of the Kansas Department for Children and Families, whose address is, 555 S Kansas Avenue, DCF Administration Building, Topeka, Kansas 66603, hereinafter referred to as "DCF" or "Secretary."

WHEREAS, Foster Adopt Connect, Inc GRANTEE Foster Adopt Connect, Inc have executed an Agreement dated 07/01/2023, providing for certain goods and services; and

WHEREAS, Agreement expires on 06/30/2024, provides for renewal options: one final remaining 1-year renewal option to be exercised in SFY25.

WHEREAS, Awardee and DCF agree to RENEW the Agreement;

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements contained herein, Grantee and DCF do hereby mutually covenant and agree as follows:

- 1) The Agreement and any addenda shall be renewed for the period beginning 07/01/2024 and continuing through 06/30/2025; compensation not to exceed \$500,000.00.
- 2) All other terms and conditions of the Agreement and addenda shall remain the same.
