3. Provide written documentation of findings to DCF.

The Grantee will provide data utilization services to DCF including:

1. Document findings regarding ways to improve services, service trends, and potential training opportunities to improve services.
2. Provide written documentation of findings to DCF for the purpose of data review.
3. Per invitation, participate in the Employment Services annual conference, to collaborate and communicate ways to improve services, service trends, and potential training opportunities to improve services based on written documentation of the data provided to the grantor.
4. Facilitate one meeting annually if needed as determined between the grantee and grantor for contracted SRCC organizations to further collaborate and communicate ways to build relationships, request DCF to present on topics such as programs or assistance, and provide the opportunity to ask questions regarding programs and specific services.
