This amendment ia required to provide a funding increase of \$597,023.00 and include additional deliverables to begin implementation of Career Pathway work. The additional Career Pathway deliverables required from KCCTO include the following:

1. By April 1, 2023, organize a steering committee ("core team") and consultants to develop and to guide the work of implementation of the Career Pathway.

2. By April 30, 2023, engage a national consulting group (e.g., BUILD) to convene Kansas partners to examine the status of and development of the Career Pathway.

By June 30, 2023, prepare a budget for expenditures of recovery dollar funds to support the implementation of the Career Pathway.
By June 30, 2023, develop a strategic plan to guide the implementation of a comprehensive Career Pathway for early care professionals in Kansas.

5. By June 30, 2023, engage the Office of Educational Innovation and Evaluation (OEIE) on the development of the research design for a comprehensive study of the current EC workforce regarding entry to and remaining in (or departure form) early care and education and design to examine the implementation and effectiveness of the Career Pathway. These supports will give

providers opportunities for advancing skills and knowledge and increase the quality of care for families and align with the existing WFD Grant. The WFD Grant Program Outcomes include:

1. Improve the skills and knowledge of the future and existing workforce.

2. Demonstrate availability to work with all child care professionals and local, regional, and state-level agencies and organizations.

3. Coordinate and collaborate a network of services to support DCF CCDF quality programs, including but not limited to, Links to Quality, the Kansas quality rating improvement system, and Infant-Toddler Specialist Network.

This amendment revises the new total grant amount to \$3,647,666.00 with utilizing additional ARPA Supplemtal Discretionary Funds. As a result, the line item allocations were increased by following amounts: Fringe Benefits \$25,116; Travel, \$59,340; Supplies \$29,850; Contractual \$366,000; Building \$1,800; Training \$107,270 & Indirect Costs \$28,430. The amendment further adjusts line item funding by reducing the Personnel line item allocation by \$20,783.00.
