2) Amending to remove prohibited language in NOGA: 9.2 Services to be Provided: Remove "To ensure cultural competency within their program, all district staff participated in regular diversity, equity, and inclusion training (DEI). In addition, their district partners with a DEI coach that regularly engages with district staff in all buildings K-12. The goal of this coach is to assess where the district is currently in their equity practices and work alongside them to identify action steps to continually improve and maintain cultural competencies across all district programs."

3) All other terms and conditions of the Agreement and addenda shall remain the same.
