

KANSAS DEPARTMENT FOR CHILDREN AND FAMILIES ECONOMIC AND EMPLOYMENT SERVICES (EES) ORGANIZATIONAL DETAILS AND STRUCTURE

Supplemental Nutrition Assistance Program (SNAP) is state administered in Kansas by the Kansas Department for Children and Families (DCF) Economic and Employment Services (EES) Division. In Kansas, the program is known as the Food Assistance Program and EES Eligibility Staff determine and administer eligibility for multi-program functions which include but not limited to; SNAP, Temporary Assistance for Families (TANF), and Child Care programs. The State agency portion of administrative costs are carried by the State and no county or local state funds are incurred.

Kansas DCF employs the following full-time Performance Reporting System (PRS) Coordinator that is responsible for supervision of Management Evaluation (ME) reviewer staff (ME reviews multiple programs), Quality Control (QC) reviewer staff (QC only reviews SNAP), and Corrective Action Plans (CAPs):

In Kansas, the Office of Administrative Hearings (OAH) conducts both fair and fraud administrative hearings. 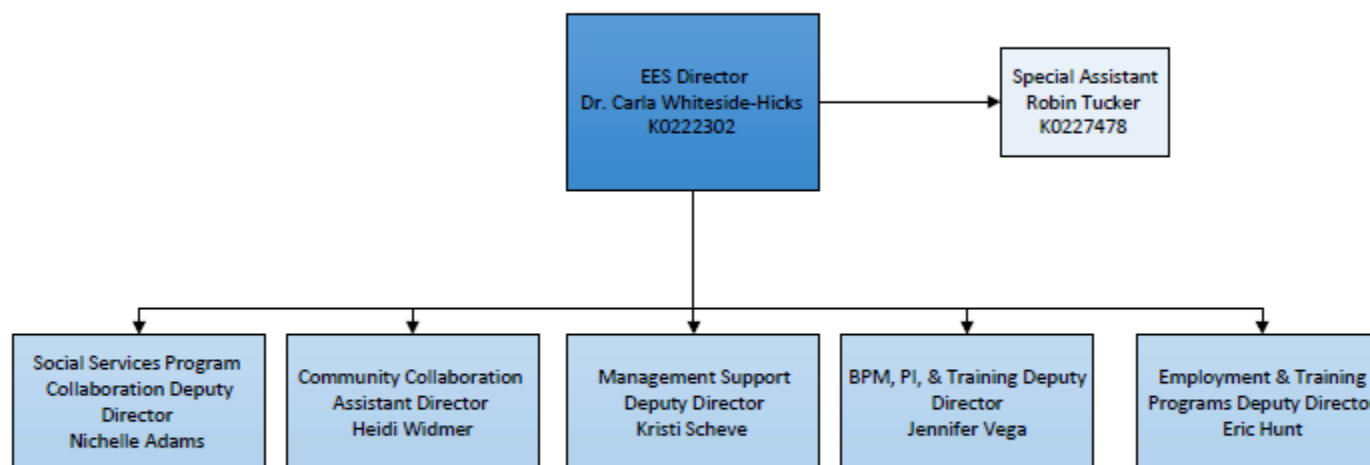

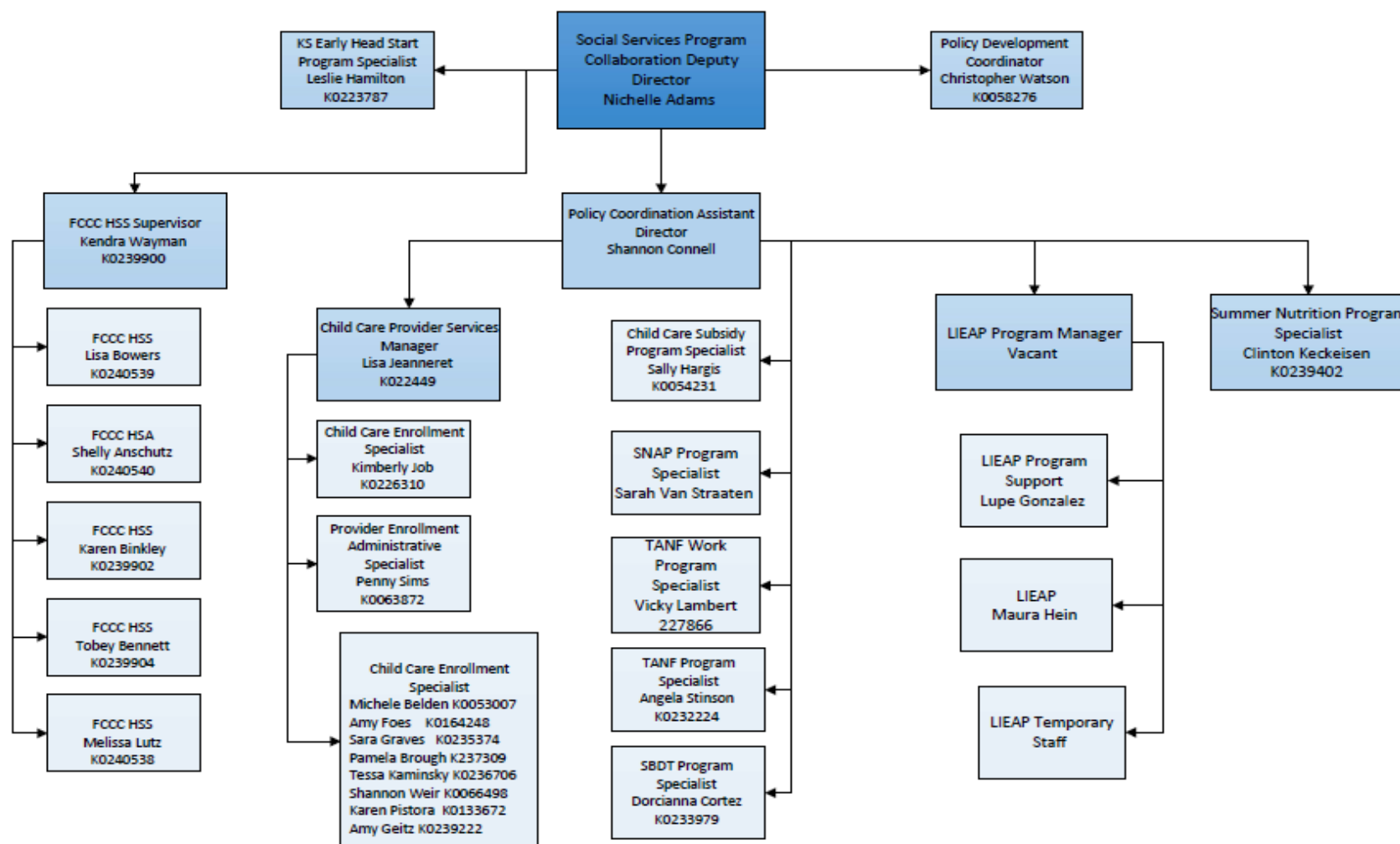

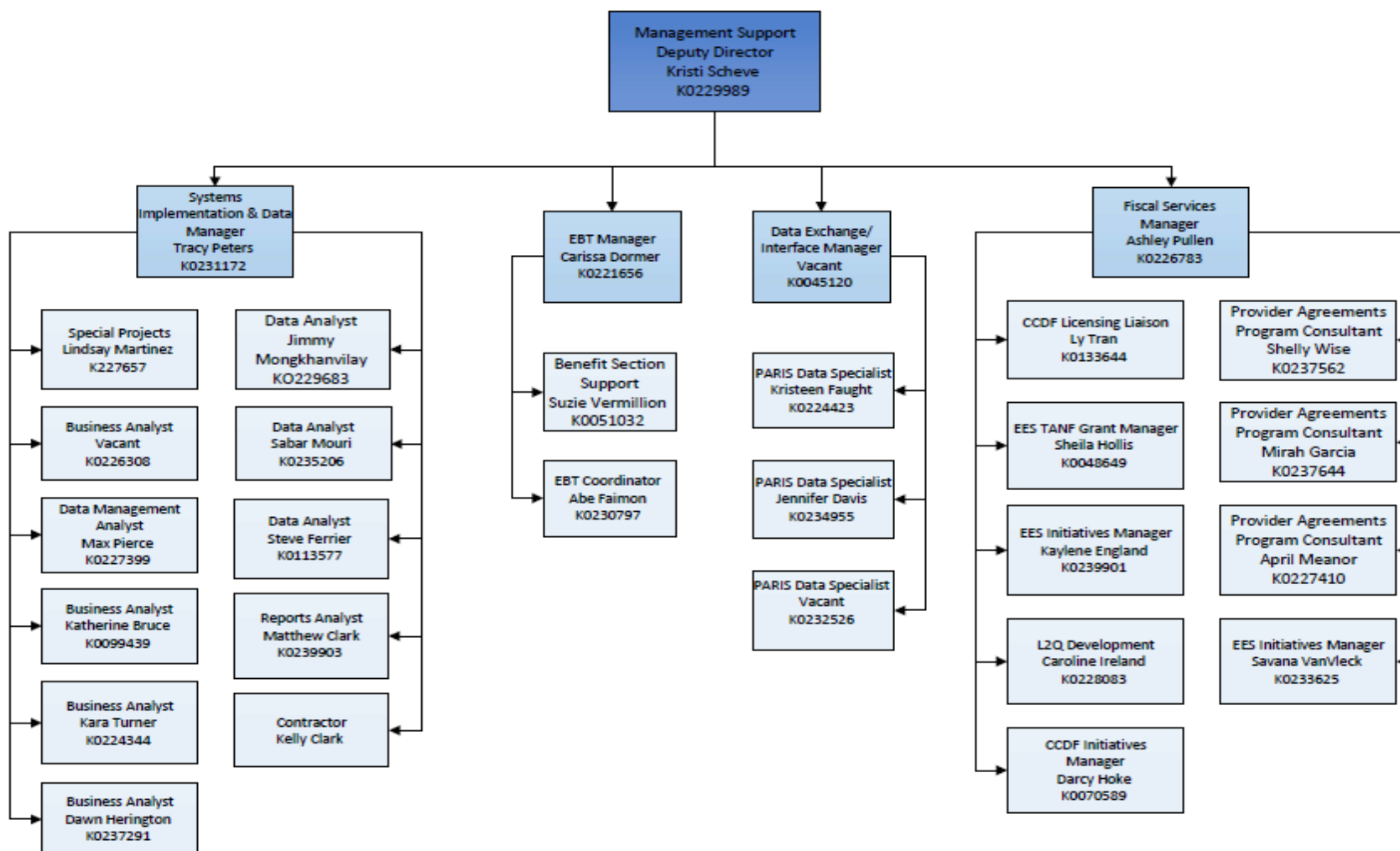
ORGANIZATIONAL CHART EES LEADERSHIP



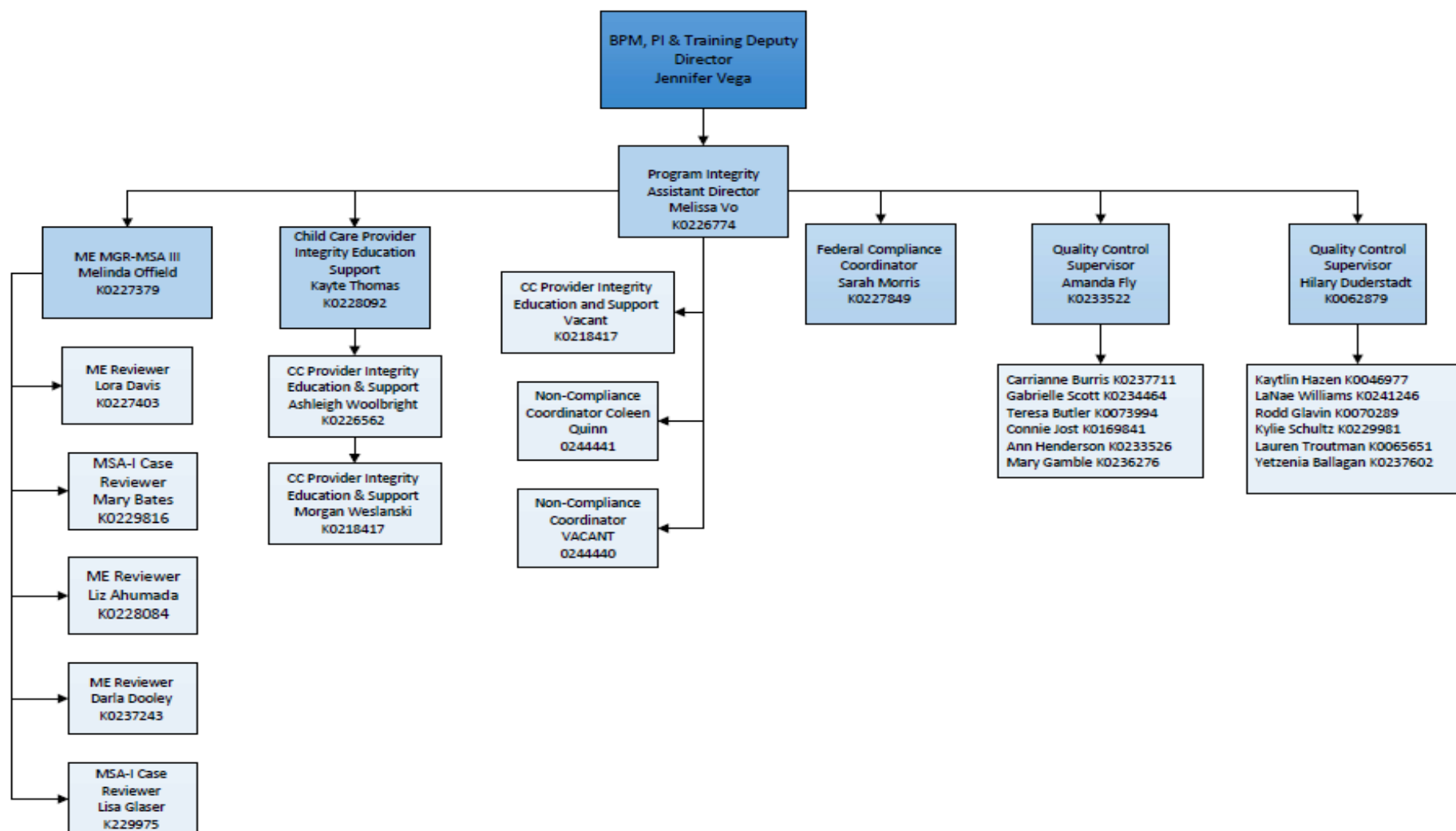
ORGANIZATIONAL CHART EES PROGRAM MANAGEMENT



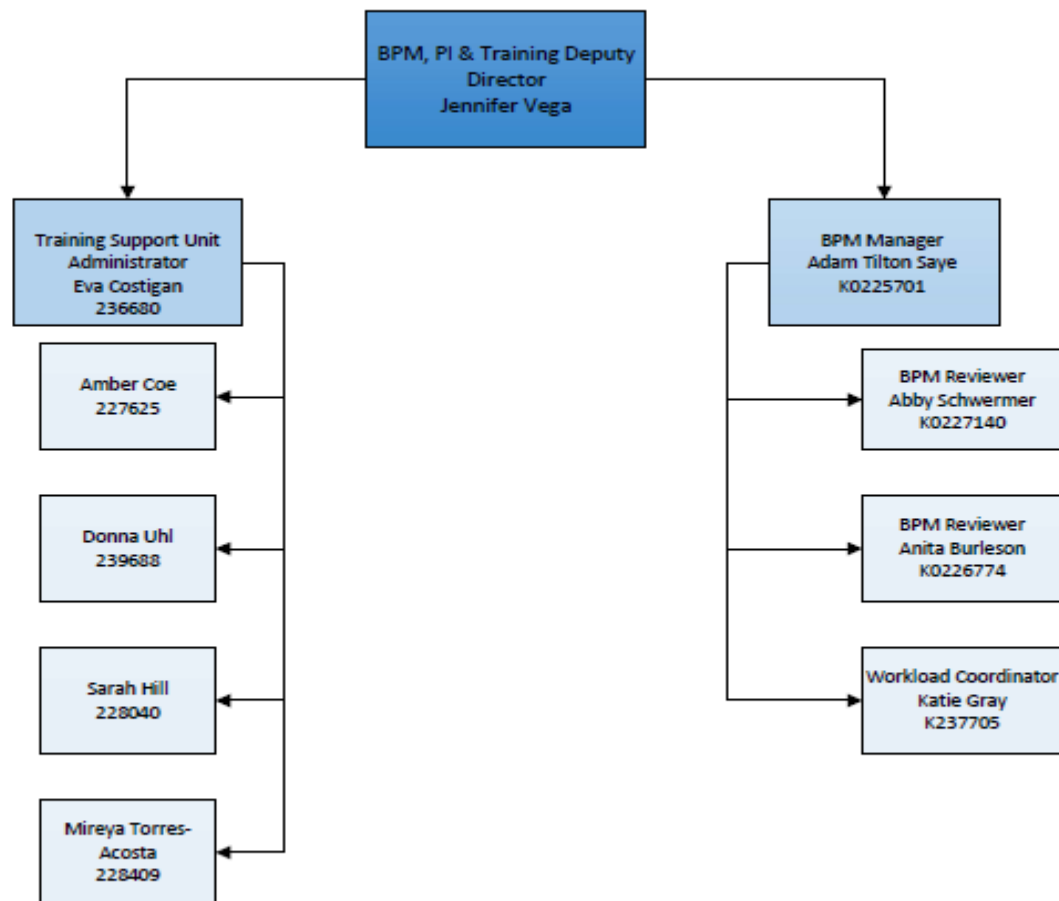
ORGANIZATIONAL CHART EES MANAGEMENT SUPPORT



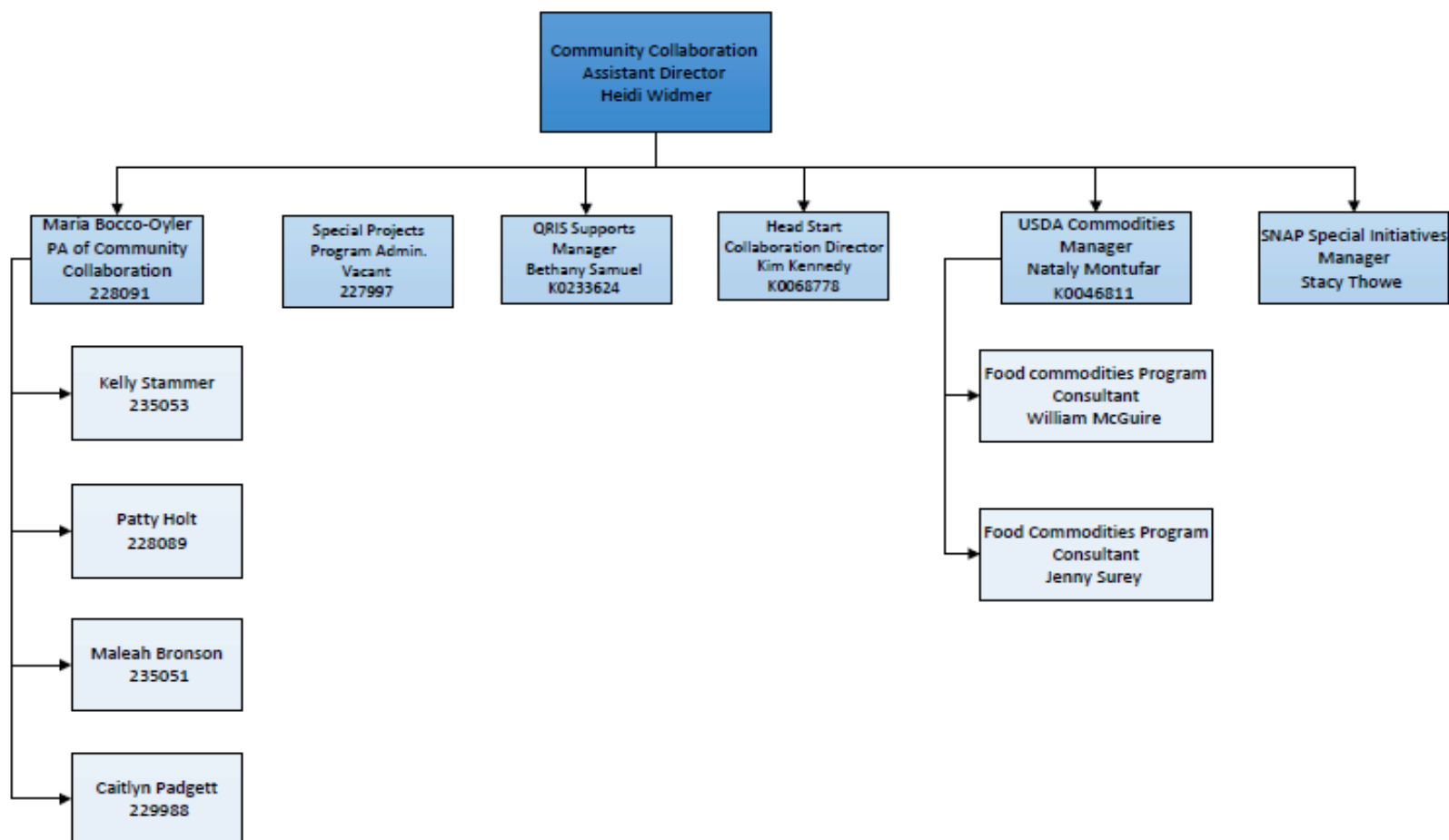
ORGANIZATIONAL CHART EES PERFORMANCE IMPROVEMENT



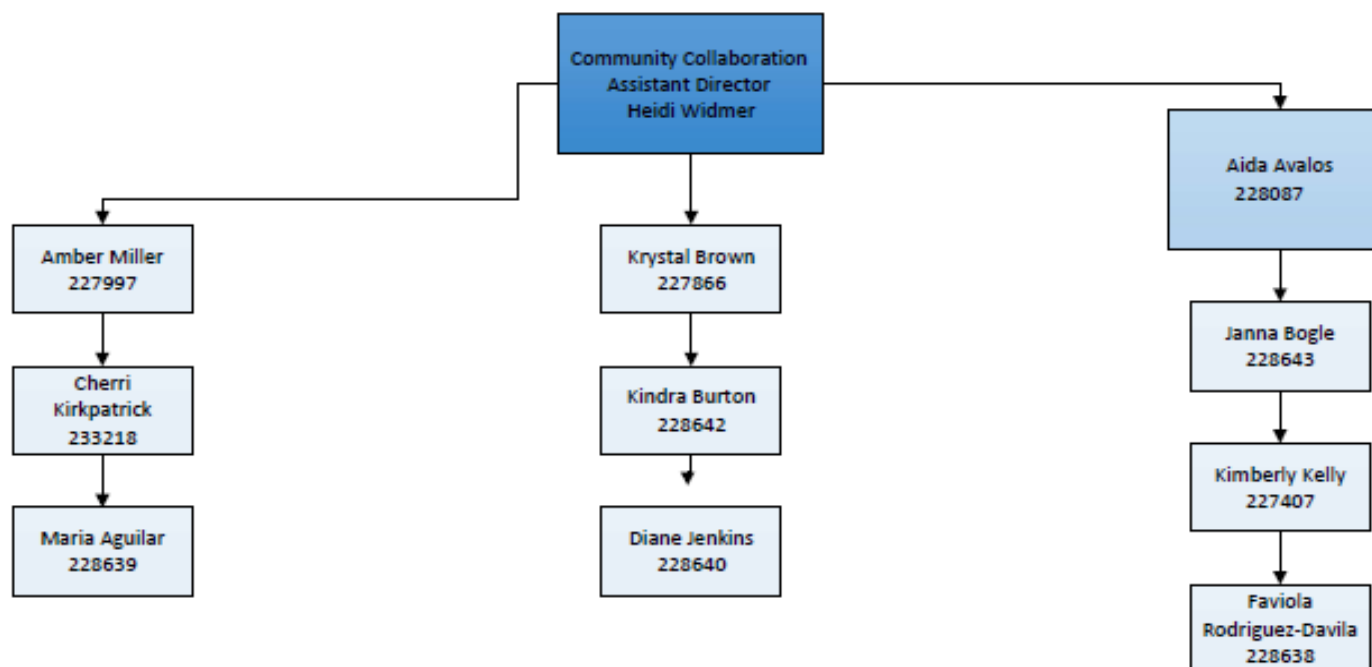
ORGANIZATIONAL CHART EES BUSINESS PROCESS MANAGEMENT (BPM) AND TRAINING



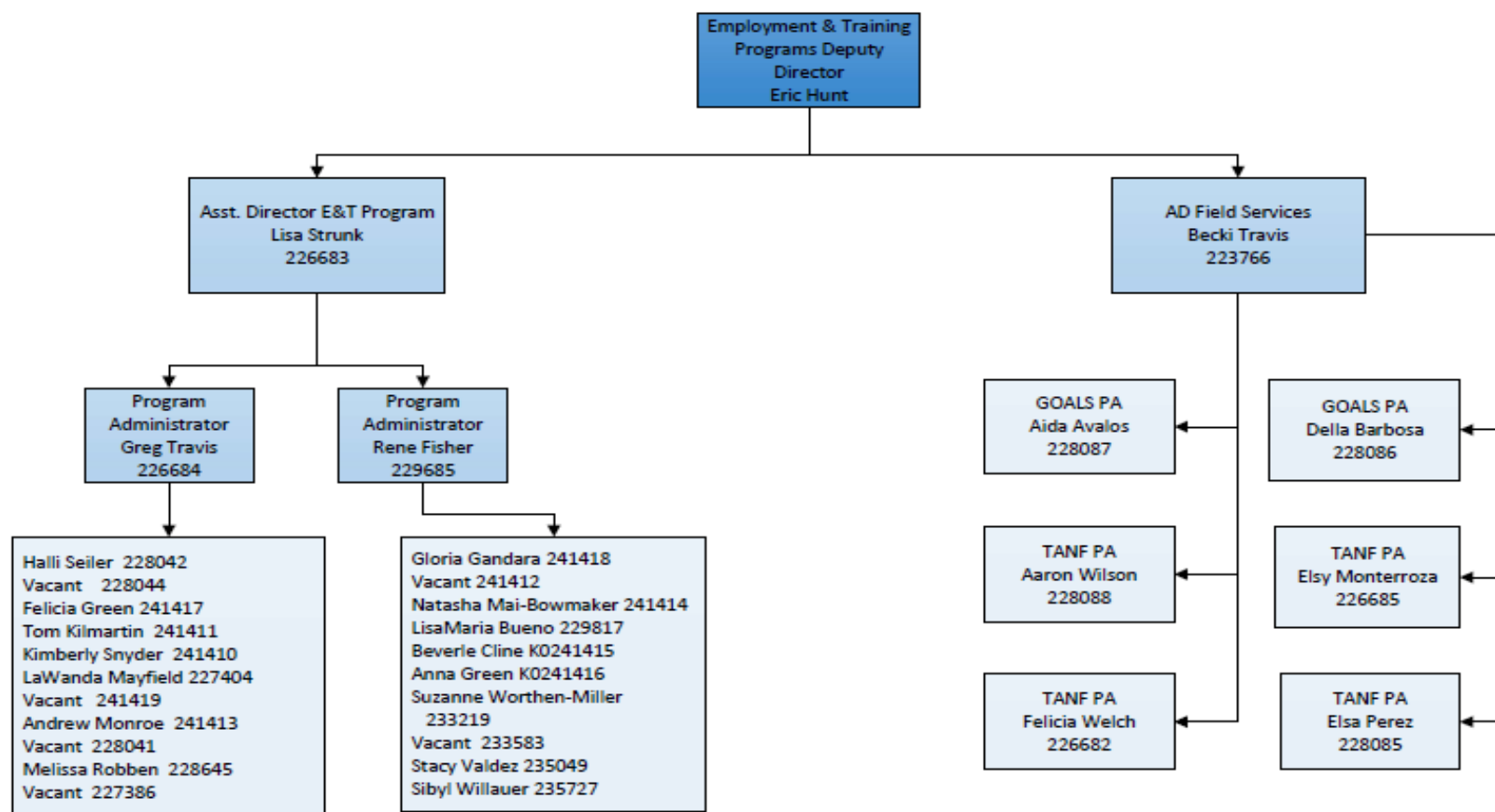
ORGANIZATIONAL CHART EES COMMUNITY COLLABORATION



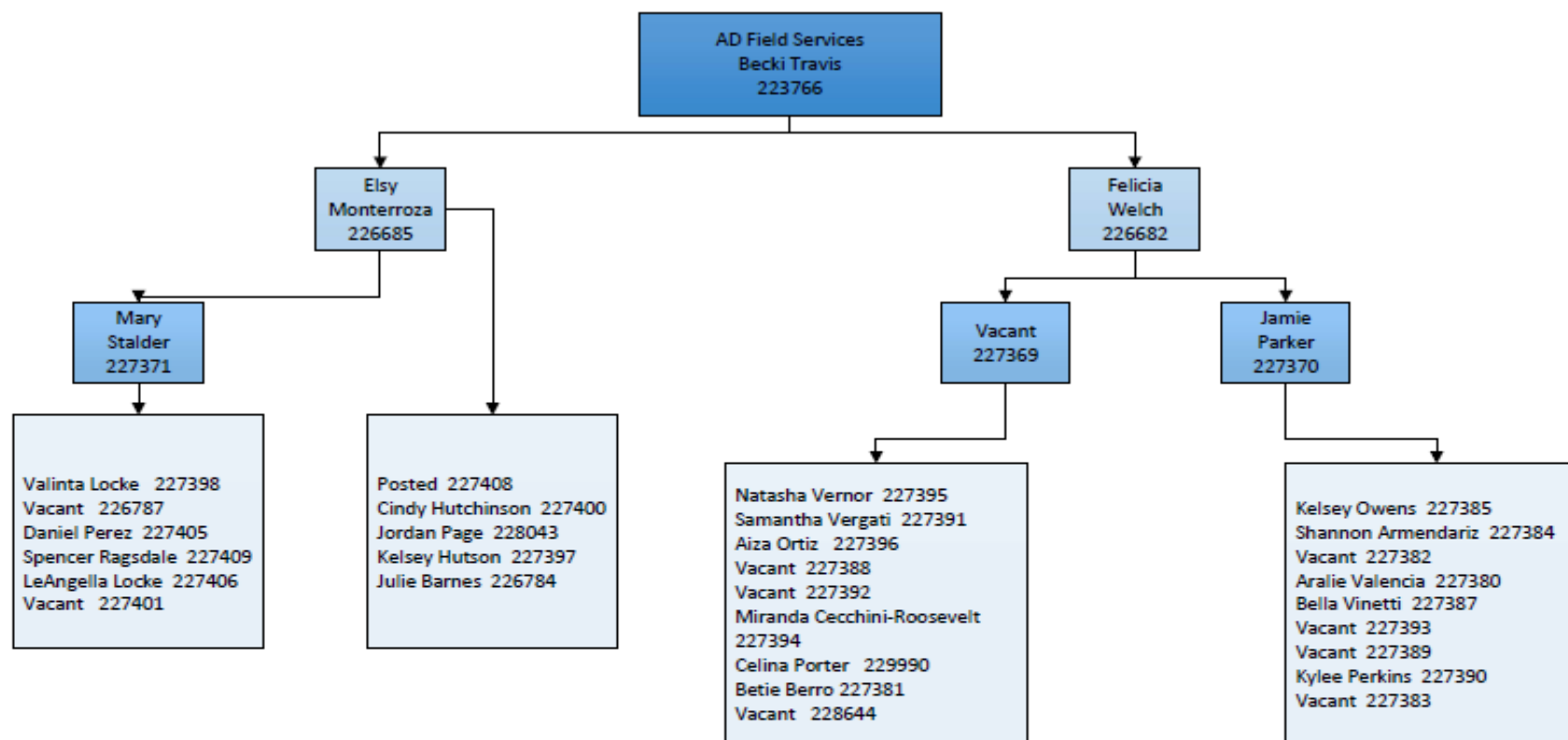
